AIMS AND OBJECTIVES OF THE TRUST ;

1. To establish and provide educational facilities at all levels viz., nursery, primary, secondary, collegiate, technical, medical, commercial, legal vocational, religious, professional etc.,
2. To establish and run residential schools, colleges, hostels, hospitals, orphanages, community halls, etc.; and to take over affiliate and run institutions of all kinds.
3. To undertake publishing of magazines, books, journals and to conduct educational literacy and cultural activities of all kind.
4. To provide special interest to minorities, SC and ST community.

RULES AND REGULATIONS OF THE TRUST :

1. All the trustees shall be permanent and life Trustees there shall be provision to removing any Trustees except in the case of death or resignation. How ever even such cases the legal heirs of the permanent Trustees shall be included in the Trust, If any Trustee acts against interest of the Trust that may effect a main and objects can be replaced by 2/3rd majority.
2. In case of death or resignation or resignation of President or Secretary, the permanent Trustees may elect the person to there two posts by 2/3 majority.

POWERS OF THE TRUST :













1. The Trust shall have powers to purchase or sell of mortgage both movable and immovable properties of the Trust.
2. The Trust shall powers to take on lease or leased out any property belongs to the Trust.
3. The Trust shall have powers to raise loan from the nationalized banks or private financial institutions.
4. The Trust shall have powers to get financial assistance or grants from international agencies for Trust developments

5. The Trust shall powers to deal with any other Trust or society having similar Aims and objects and amalgamate or Transfer any Institutions run by any other Trust or Society with an unanimous resolution by both the Trust.
6. The Trust shall powers to take over any other Institutions run by registered trust or Society with an unanimous resolution.
7. The Trust shall have powers to remove any Trustee if he acts against the interest of the Trust or found guilty by 2/3rd majority.

POWERS AND DUTIES OF THE TRUSTEES :

PRESIDENT :

Usually the Hon. President will preside over all the meetings including general body meetings and conduct the deliberations. He shall have full control over the Trust and its activities including Institutional run by this Trust. His decision was final and binding on all the Trustees.

SECRETARY :

1. The Secretary shall have powers to deal with day -today functioning of the Trust and its Institutions.
2. The Secretary shall convene monthly meetings and general body meeting and also maintain all financial Transactions and accounts and get them audited every year and bring before the general body meeting for approval.
3. The Secretary shall carry out such work as entrusted by the President and general body meeting. There shall be close co-operation and co-ordination between the President and the Secretary.
4. The Secretary shall have powers to appoint staff required for Trust Institutions.

MEETINGS :




The monthly meetings of the Trust shall be conducted once in a month to monitor the development of the Trust and its Institutions. The Secretary should convene all the meetings within seven days prior notice with the consultation of the President. The notice must bear date. Time and venue of such meetings.

GENERAL BODY MEETING :

The general body meeting shall be convened by the secretary once in a year preferably after the completion of financial year and finalization of accounts and its audits. Such meetings requires 15 days notice prior to the meeting. The Secretary shall send the notices with agenda, date, time and venue of the such meeting. A special general body meeting shall be convened at any time within a short notice in case of emergency, such meetings should have concurrence with the president and the secretary.

ACCOUNTS :

The Accounts of the Trust and its institutions shall be opened in any nationalized bank and to be operated jointly by the Secretary and Treasurer.





